

## *Win a Car for a Year*

### **Terms and Conditions**

1. This competition is a promotion run by The Royal Automobile Club of Queensland Limited ABN 72 009 660 575 ("**Promoter**").
2. Entries and information on prizes and how to enter form part of these terms and conditions ("**Terms**"). Entries not completed in accordance with these Terms are ineligible. Participation in this competition constitutes acceptance of these Terms.
3. The competition is open to RACQ members who are residents of Queensland and who are over the age of 18 years of age at the time the competition is drawn.
4. Employees and their immediate families of the Promoter, related entities and agents of the Promoter are ineligible to enter.
5. The competition commences at 9am on Wednesday, 1 February 2012 and closes at 5pm on Saturday 31 March 2012 (promotional period). 9. The winner will receive a Hyundai i30 car for twelve consecutive months, valued at \$15,600, including premium protection accident liability coverage, provided by Thrifty.
