

CTP: RACQ Membership Discount Offer Conditions

- a) RACQ Blue, Bronze, Silver, Gold and Gold 50 members who do not have RACQ Ultra Care or RACQ Ultimate are entitled to \$10 off the Roadside portion of their RACQ annual membership subscription fee if the relevant vehicle is nominated for both RACQ roadside assistance and CTP Insurance with RACQ Insurance.

b) To qualify for this discount, the name of the RACQ member (and/or spouse) and the registration number of their vehicle recorded on RACQ's records must match with the name of the registered owner and the registration number of the corresponding vehicle nominated for CTP Insurance with RACQ Insurance. RACQ Lifestyle members cannot participate in the CTP Membership Discount scheme regardless of loyalty level, as they do not have a vehicle nominated on their membership.
- a) RACQ Blue, Bronze, Silver, Gold and Gold 50 members who have RACQ Ultra Care or RACQ Ultimate are entitled to a discount of \$10 per vehicle off the Roadside portion of their RACQ annual membership subscription fee for up to three (3) vehicles, even though only one of the vehicles must be nominated for RACQ roadside assistance.

b) To qualify for this discount, the name of the RACQ member (and/or spouse) and the registration number of their vehicle/s recorded on RACQ records must match with the name of the registered owner and the registration number of the corresponding vehicle/s nominated for CTP Insurance with RACQ Insurance. RACQ Lifestyle members cannot participate in the CTP Membership Discount scheme regardless of loyalty level, as they do not have a vehicle nominated on their membership.
- For any discount to apply the vehicle must be registered in Queensland in one of the following classes listed in the Motor Accident Insurance Regulation 1994. Class 1: Cars and Station Wagons. Class 2: Motorised Homes (but not if the part of the motor vehicle designed for residence is detachable from the part providing the motive power). Class 6: Trucks, Utilities and Vans (including Panel Vans) with a gross vehicle mass of 4.5t or less. Class 12: Motor Cycles (with 2 or 3 wheels) including motor cycles for hire, with seating only for the driver. Class 13: Motor Cycles (with 2 or 3 wheels) including motor cycles for hire, with either or both of the following - a sidecar - seating for a pillion passenger.
- The Compulsory Third Party Insurance Nomination Notice attached to this brochure must be completed in full showing RACQ Insurance as the nominated CTP insurer and the form must be signed and dated by the registered owner of the vehicle. The form must be posted to RACQ Insurance, Membership Discount for CTP, Reply Paid 4, Springwood BC Qld 4127 or handed in to an RACQ store or RACQ Insurance agent in Queensland.
- Total discounts will be limited to a maximum dollar value no greater than the member's RACQ membership subscription for that year. There will be no credits for unused discounts or part thereof and unused discounts will not be carried forward. 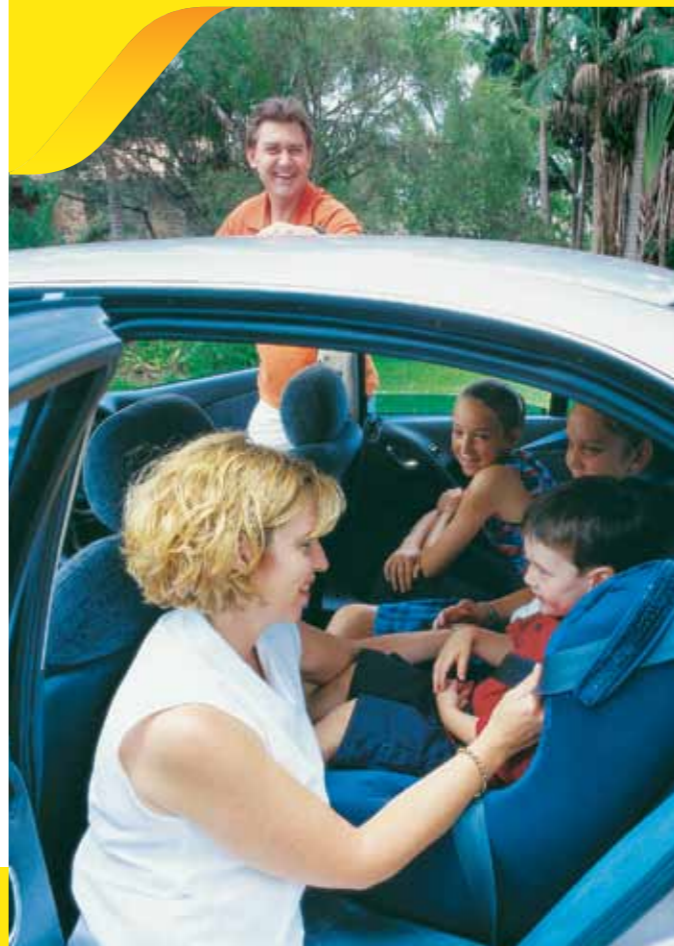

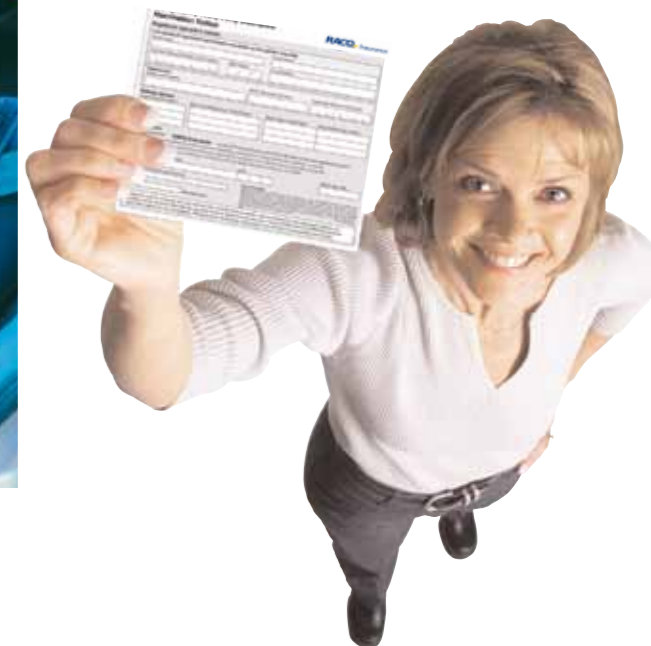

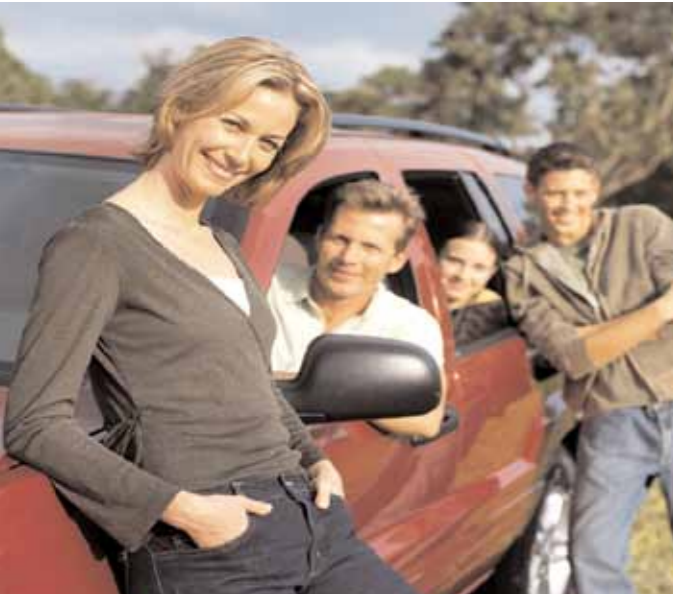

* At Fault Driver Injury Insurance is only available on vehicles classified by the Motor Accident Insurance Regulation 1994 as solely Class 1 (cars and station wagons) or Class 6 (trucks, utilities and vans of 4.5 tonnes or less) and was not a vehicle owned or operated by police.
